

ABOUT OUR FOUNDER, MR. STANLEY G. TATE



Mr. Stanley G. Tate was instrumental in the creation and early development of the Florida Prepaid College Program. It was his vision to provide Florida families with an affordable means to save for their children's future college education. Mr. Tate served tirelessly as Board Chairman from 1987 to 2005. In recognition of Mr. Tate's service, Governor Jeb Bush signed House Bill 263 into law on June 26, 2006, renaming the program the Stanley G. Tate Florida Prepaid College Program.

Highlights of Mr. Tate's leadership include:

- More than 58,000 tuition and dormitory contracts sold in the first year.
- In 1989, two years ahead of schedule, Mr. Tate presented the State of Florida a check for \$600,000, repaying a start-up loan made by the Legislature to help launch the program. From this point forward, the program has remained fully self-supporting.
- In 1990, the Florida Legislature created the Stanley Tate Project STARS
 scholarship program to be administered by the Stanley G. Tate Florida Prepaid
 College Foundation. Project STARS helps economically disadvantaged students
 who are at risk of dropping out of school by providing them with the opportunity
 for a college education.
- In 2002, under Mr. Tate's leadership, the Board created the Florida 529 Savings
 Plan to provide families another way to save for college tuition, fees, housing and
 other college expenses.
- At the Florida Cabinet meeting on November 8, 2005, Governor Jeb Bush and the Florida Cabinet issued a resolution recognizing Mr. Tate's exemplary record of professional and dedicated service to the families and children in Florida.
- While Mr. Tate served as Chairman of the Board, more than 1 million total contracts were purchased, and more than 142,000 children used their plan benefits to attend a college or university. In addition, 15,472 scholarships were awarded to Stanley Tate Project STARS students, helping Florida's children build a better future through a college education.

Generous partnerships with individuals, families, the Florida Legislature, businesses and numerous non-profit foundations make these scholarships possible. To date, the Foundation has awarded 37,665 Prepaid College Plan scholarships and more than 20,800 Foundation scholarship recipients have gone to college using their benefits.


The Scholarship Tuition for At-Risk Students (STARS) Program is the Foundation's largest initiative, representing 29,000 of the scholarships purchased by the Foundation. Project STARS provides Florida Prepaid College Plan scholarships to low-income students who are at risk of dropping out of middle and high school, giving them the incentive and opportunity to plan and prepare for college. Project STARS scholarships are funded from an annual legislative appropriation and matching contributions from partners, including Take Stock in Children, local education foundations, school districts and other community-based organizations.

Businesses, hospitals, churches and community groups may also purchase private Foundation scholarships, covering 100 percent of the scholarship cost and fully designating their own criteria.

On behalf of the Foundation Board, I would like to extend my gratitude and appreciation to Governor Rick Scott, the Florida Legislature, community organizations, businesses, mentors, teachers and parents for their continued support.

The Florida Prepaid College Foundation is committed to giving aspiring students the opportunity to build a better future for themselves and our state by providing college scholarships funded through partnerships with individuals, families, the Florida Legislature, businesses and educational foundations with an unparalleled level of efficiency.

FOUNDATION FACTS

The Stanley G. Tate Florida Prepaid College Foundation ("Foundation") provides a tax-deductible opportunity for businesses, community groups, and other 501(c)(3) not-for-profit groups to purchase Florida Prepaid College Plan scholarships for Florida children.

The Florida Prepaid College Plan has an annual enrollment period from October to February. Through the Foundation, scholarships may be purchased from October through August.

- Foundation scholarships may be purchased for an unnamed beneficiary (student), giving the donor the flexibility to assign the scholarship to another student if the original beneficiary does not use the scholarship.
- Foundation scholarships may be purchased for children through the 12th grade. The children must be Florida residents at the time of selection and award.
- Stanley Tate Project STARS scholarships may be purchased for children through the 11th grade. The children must be Florida residents at the time of selection and award.
- The cost of the scholarship is based on the type of plan and the projected college enrollment year. Foundation scholarships must be paid for in a single lump sum.
- There is no application process for the donor. Donors simply provide the Foundation the type of plan they want to purchase, the projected college enrollment year, and a summary of the scholarship award criteria. The Foundation coordinates the purchase and the administration of the scholarship.
- The donor typically selects the student. Foundation scholarships can be used at any of Florida's 12 public universities or 28 state colleges, including the 24 colleges currently offering baccalaureate degrees. The value of the scholarship may also be transferred to most private colleges in Florida, select technical schools in Florida and most out-of-state colleges. The Florida Prepaid College Plan may be used at an eligible education institution as defined in section 529 of the Internal Revenue Code.
- Stanley Tate Project STARS beneficiaries are required to submit a student information form annually, prior to the beginning of the fall semester, to update the Foundation on their academic progress. Terms of participation are outlined in the policies and procedures of the Foundation (available upon request).
- All other terms of participation are the same as the Florida Prepaid College Plan.
- When Foundation students are ready for college, they receive a Florida Prepaid College
 Plan student identification card. The student presents this card when registering for classes.
 The college will bill the Florida Prepaid College Plan, which will pay the college directly for
 the fees covered by the scholarship.

FOUNDATION SUMMARY

The Foundation is the 501(c)(3) direct support organization for the Florida Prepaid College Board, which operates and oversees the Florida Prepaid College Plan.


The Foundation was created in 1990 as a public/private partnership to provide scholarships to students who may not have otherwise had the opportunity to go to college. Scholarships are awarded to economically disadvantaged students who are at risk of dropping out of school, and to other deserving students in need of assistance. Many of the recipients are the first in their family to attend college.

Businesses, organizations and community groups may purchase contracts through the Foundation. Since its inception, the Foundation has purchased 37,665 Florida Prepaid College Plan scholarships and, as of Fall 2014, more than 20,800 Foundation scholarship recipients have gone to college using their benefits.

PLANS OFFERED

Foundation donors can choose from five different Florida Prepaid College Plans:

- 2-Year Florida College Plan (covers 60 lower division Florida College credit hours)
- 2-Year Florida College Foundation Plan (covers 72 lower division Florida College credit hours)
- 4-Year Florida College Plan (covers 60 lower division Florida College credit hours and 60 upper division Florida College credit hours)
- 2 + 2 Florida Plan (covers 60 Florida College lower division credit hours and 60 university undergraduate credit hours)
- 4-Year Florida University Plan (covers 120 university undergraduate credit hours)



DORMITORY SCHOLARSHIPS

The Foundation also offers optional, supplemental Dormitory Plan scholarships. The Dormitory Plan covers the cost of a standard, double-occupancy, air-conditioned dorm room at a Florida state university. The Dormitory Plan can be used toward the cost of other university-held housing, including some fraternity and sorority houses, and at select Florida Colleges. The Dormitory Plan can be purchased in one-year increments, up to a total of four years. The Plan may be purchased for a student with a 4-Year Florida University Plan, a 2 + 2 Florida Plan, a 4-Year University Tuition Plan or a 2 + 2 Tuition Plan. To date, 836 dormitory scholarships have been awarded by the Foundation.

STANLEY TATE PROJECT STARS SCHOLARSHIP PROGRAM

Stanley Tate Project STARS (Scholarship Tuition for At-Risk Students) is the Foundation's largest program, representing 29,000 of the scholarships purchased by the Foundation. STARS is a matching scholarship program funded annually by the Florida Legislature and matched dollar-for-dollar by private sector donations. STARS targets low-income students who are at risk of dropping out of school and gives them the incentive and opportunity to plan and prepare for college.

STARS DONORS

STARS donors include a notable group of public school foundations, school districts, community groups, businesses and other 501(c)(3) organizations that are dedicated to providing the children of Florida with guidance and educational opportunities.

STARS STUDENTS

To qualify for a STARS scholarship, students must be residents of Florida, economically disadvantaged (eligible for the free or reduced lunch program), at-risk of dropping out of school and remain drugfree and crime-free. STARS students must also progress academically, meet school attendance requirements, abide by his/her school's code of conduct and meet with a mentor on a regular basis. STARS donors monitor each student's progress, providing support and encouragement throughout his/her middle and high school years.




STARS STUDENT STATISTICS


STARS scholarships continue to have a tremendous impact on the lives of their recipients. Among the recipients, 84.4 percent of the students are meeting the Stanley Tate Project STARS Scholarship Program requirements and are preparing for college.


Since inception, 15.6 percent of STARS students did not meet the STARS requirements and, therefore, were terminated from the program. Additionally, 7.0 percent of STARS students voluntarily withdrew from the program. Students who withdrew voluntarily have moved out-of-state or have received other college scholarships.

VICTOR SIMS

Polk Education Foundation

Current Status: College Student

In 1996, at three months old, Victor Sims entered foster care because of violence in his home. By the age of 11 Victor had been in 8 different foster homes. But, when Victor was 11 he went to live with Ron and Violet Sims, who adopted Victor in 2007. "I think God gave me all the families for a reason," Victor said. "One family taught me that attendance in school was important. Another family encouraged higher grades. I never missed another day of school, and my grades went from C's to A's." Victor graduated from Chain of Lake Collegiate High School before earning his associates degree at Polk State College. In 2013, Foster Club, a national network for those served by foster care, awarded Victor the Foster Club Outstanding Young Leader award. He is currently studying Psychology at the University of South Florida, St. Petersburg.



PAULINA RIPPERE

Monroe County Education Foundation

Current Status: College Graduate

Paulina graduated with a bachelor's degree in political science from the University of Central Florida. She then attended the University of Florida where she received her PhD in political science in May 2013. Now, Paulina is an Assistant Professor of Political Science at Jacksonville University. Last spring she was awarded a Congressional Fellowship from the American Political Science Association and will spend the 2014–2015 academic year in Washington, D.C. as a legislative aid to a member of Congress.



JESUS ABARCA JR.

The Immokalee Foundation

Current Status: College Graduate

Jesus Abarca Jr.'s parents emigrated from Mexico to the United States for him to have a chance at a better life. After receiving a scholarship from the Immokalee Foundation, he attended Florida Gulf Coast University where he completed his associate's degree. Then, he transferred to Florida State University and graduated with a bachelor's degree in Economics. Today Jesus works for North America's largest tomato field grower, Lipman Produce. Jesus is currently a management trainee in Lipman Produce's operations division where he is working hard to ascend the ladder. Jesus says he is very grateful for the impact that his scholarship has had on his life. "I am doing what so very few people get the opportunity to do in their life," he says, "chase their dreams."



GABBY CRUZ

Public Education Foundation of Marion County

Current Status: High School Student

During Gabby's 8th grade year her mother was diagnosed with cancer. Despite the turmoil she was experiencing, Gabby applied for the Take Stock in Children program with hopes of receiving a scholarship. In her sophomore year of high school, Gabby's mother passed away and she was left to be raised by her older brother. While Gabby's path to college has been difficult she credits her mentor for helping overcome these hardships. Gabby now has a 4.0 grade point average, is the Executive Officer of her school's ROTC, is dual-enrolled through the Career Academy and also works part-time at a local Panera Bread. She plans to attend the University of South Florida after graduation and earn a bachelor's degree in biomedical science. She then plans to complete medical school and specialize in oncology – to help battle the disease that took her mother.



TONY BLANDING

Charlotte Local Education Foundation

Current Status: College Student

Tony Blanding came into the Take Stock in Children program in Charlotte County as an 8th grader in 2009. He and four of his siblings lived with his great grandmother until she passed away in 2012. After that his family was separated and Tony moved in with a young aunt. Tony was paired with mentor Mike Riley, who has mentored students in Charlotte County since the inception of the county's Take Stock in Children program. As a high school student Tony was able to attend the Seminar for Tomorrow's Leaders for a weeklong leadership program in Lakeland, FL. He was recognized for his outstanding participation, his leadership qualities and was invited back as a leader. Tony currently attends Florida SouthWestern State College in Fort Meyers where he received a housing scholarship.



FOUNDATION PRIVATE DONORS

The Foundation has many private donors, including community groups, businesses, hospitals, churches, and individuals, that are making a college education a reality for students in their communities throughout Florida. These private donors purchase Foundation scholarships with 100 percent private sector donations which permits them to set their own selection criteria. Since 1990, the Foundation has had 88 different private partners that have purchased 5,451 tuition scholarships. This year, the three private donors listed below purchased 96 scholarships:

FOUNDATION INNOVATIONS

GOVERNOR'S RECOGNITION SCHOLARSHIP

Since 1999, the Foundation has annually awarded college scholarships in honor of past Florida governors through the Governor's Recognition Scholarship Essay Contest. Each year the Foundation Board randomly selects a small group of counties to participate and opens the essay contest to seventh and eighth grade students who qualify for project STARS. Eligible students write a 500word essay. The theme of the essay is "Choose one former governor of Florida and describe his most significant impact on the Sunshine State and your life today." The winning student receives a 2 + 2 Florida Plan scholarship. The school districts help administer the contest and students submit their essays directly to the Foundation. A panel of judges receives the top five essays from each county and selects the winning essay. The scholarship is awarded at a school board meeting in each participating county. This year, the Foundation Board selected Bay, Brevard, Escambia, Gulf, Highlands, Lee, Polk, St. Johns and Suwannee to participate in the annual Governor's Recognition Scholarship essay contest.

The winners were Hannah Presley from Bay County; Justin Waters from Brevard County; Tavaius Dawson from Escambia County; Joshua Butts and Chance Pittman from Gulf County; Madison Thomas from Highlands County; Harrison Strohl from Lee County; Cristal Perez from Polk County; MacKenzie Reid from St. Johns County; and Shawn Topham from Suwannee County. The Foundation provided each winning student with a scholarship valued at over \$15,465. The scholarships totaled \$154,650.

HISPANIC HERITAGE MONTH SCHOLARSHIP

For the 12th year, the Foundation sponsored the Governor's Annual Hispanic Heritage Month Essay Contest for 4th through 12th grade students throughout Florida. The essay contest celebrates Hispanic heritage, family and culture. The Florida Prepaid College Foundation donated a 4-Year Florida College Plan to each of the three winners at an awards ceremony at the Governor's Mansion, hosted by Lt. Governor Carlos Lopez-Cantera. The theme of the 2014 essay contest was "Hispanic Culture: Living the American Dream in Florida."

The winners were Daniel Fernandez from Devon Air K-8 Center in Miami; N'Jhari Jackson from The Paideia School of Tampa Bay in Tampa; and Will Radka from Winter Springs High School in Winter Springs. The Foundation contributed \$50,820 to purchase these three scholarships.

BLACK HISTORY MONTH SCHOLARSHIP

For the 12th year, the Florida Prepaid College Foundation sponsored the Governor's Annual Black History Month Essay Contest for 4th through 12th grade students throughout Florida. The essay contest celebrates Black History Month and honors the historic contributions and accomplishments of African-American leaders, educators, and entertainers from Florida. The Foundation donated a 2 + 2 Florida Plan to each of the three winners during a reception at the Governor's Mansion commemorating Black History Month. The theme of the 2014 essay contest was "Dr. Martin Luther King's Dream: 50 Years in Action."

The year's winners were Brooklyn Sheppard from Port St. Joe Elementary School in Port. St. Joe; Lyndsey Thomas from Franklin Academy in Pembroke Pines; and Javan Latson from Belleview High School in Belleview. The Foundation provided each winning student with a scholarship valued at \$15,465. The scholarships totaled \$46,395.

SPECIAL SCHOLARSHIPS

The Florida Prepaid College Foundation provides scholarships to other children who have special circumstances that may have otherwise kept them from going to college. The Foundation Board, on a case-by-case basis, reviews petitions for these special scholarships.



FINANCIAL SUMMARY OF THE STANLEY G. TATE FLORIDA PREPAID COLLEGE FOUNDATION
