Chairman's Message



It is my pleasure to share with you the Stanley G. Tate Florida Prepaid College Foundation Annual Report for the Fiscal Year ending June 30, 2022. This past year has been a momentous chapter in the Foundation's more than three-decade history, with continued growth in our statewide initiative aimed at opening the door to higher education for students living in Florida's poorest zip codes. We also continue to partner with donors from across Florida to help make college a reality for aspiring students, giving them the opportunity to build a stronger future for themselves and our communities.

To date, the Foundation has awarded nearly 58,000 Florida Prepaid College Plan scholarships, and more than 33,000 Foundation scholarship recipients have gone to college using their benefits. The Scholarship Tuition for At-Risk Students (STARS) Program remains the Foundation's largest initiative, representing 82 percent of the scholarships purchased by the Foundation.

Project STARS provides Florida Prepaid College Plan scholarships to low-income students who are at risk of dropping out of middle and high school, giving them the incentive and opportunity to plan and prepare for college. Project STARS scholarships are funded from an annual legislative appropriation and matching contributions from partners, including Take Stock in Children, local education foundations, school districts and other community-based organizations.

In May 2021, we announced with the Florida Chamber Foundation the Path to Prosperity Scholarship Program, a first of its kind initiative that brings together Florida businesses, organizations and private donors to provide up to \$20 million in college scholarships to children living in Florida's most impoverished zip codes. The Florida Prepaid College Foundation is matching dollar for dollar up to \$10 million in contributions from Florida businesses, helping thousands of Florida students achieve their potential and rise out of poverty.

We are honored to partner with donors like Florida Blue, Availity, Tampa General Hospital and others to give hope to students who need it most.

On behalf of the Foundation Board, I am grateful and appreciative for all of our donors and partners from around the state. Together, we are helping Florida students reach for a better tomorrow – and that drive will continue to make our state stronger!

Mission Statement

To promote the importance of saving for college and give aspiring students the opportunity to build a better future for themselves through higher education. To provide unprecedented value to donors by leveraging matching dollars to maximize the impact of scholarship gifts. To be guided each day by the conviction that to give is to believe in the future of our state. Giving is Believing.

Foundation Facts

The Stanley G. Tate Florida Prepaid College Foundation provides a tax-deductible opportunity for businesses, community groups and other 501(c)(3) not-for-profit groups to purchase Florida Prepaid College Plan scholarships for Florida children.

- Foundation scholarships may be purchased for an unnamed beneficiary (student), giving the donor the flexibility to assign the scholarship to another student if the original beneficiary does not use the scholarship.
- Foundation scholarships may be purchased for children through the 12th grade. The children must be Florida residents at the time of selection and award.
- The cost of a scholarship is based on the type of Plan and the projected college enrollment year. Foundation scholarships must be paid for in a single lump sum.
- There is a simple application process for the donor that includes agreeing to comply with the terms & conditions, master contract and laws governing the program.
- Donors provide the Foundation information on the type of Plan they want to purchase, the projected college enrollment year, and a summary of the scholarship award criteria. The Foundation coordinates the purchase and the administration of the scholarship.
- Foundation scholarships can be used at any of Florida's 12 public universities or 28 state colleges. The value of the scholarship may also be transferred to most private colleges in Florida, select technical schools in Florida and most out-of-state colleges.
- When students are ready for college, they enroll in classes and Florida Prepaid pays their school directly.
- The Stanley Tate Project STARS (Scholarship Tuition for At-Risk Students) scholarship program is the Foundation's hallmark program and offers a 1:1 scholarship match.
- The Challenge Match scholarship programs offer a 1:1 scholarship match and can be purchased during specific application windows.

Featured Donors & Partners

The Florida Prepaid College Foundation is proud to partner with all of the organizations we work with throughout the state.

Since 1991, the Foundation has partnered with 150 Project STARS donors. During Fiscal Year 2021-2022, 56 donors purchased 2,011 STARS tuition scholarships with privately donated funds matched by state-allocated funds. As our other programs continue to grow, we are proud that 27 donors have purchased 231 Challenge Match Scholarships. Our partners consist of education foundations, school districts, community groups, businesses and corporations dedicated to making the dream of a college education come true. This year we would like to highlight two donor partners: The Consortium of Florida Education Foundations and Big Brothers Big Sisters of Miami.

In 2021-22, we ramped up a new scholarship program with the Consortium, one of our longstanding partners. The Jump Start Scholarship Program, aims to provide a fast-track career/college strategy for high school seniors through enrollment in technical and vocational certification programs available at state colleges or technical institutions.

Big Brothers Big Sisters of Miami (BBBSM) has been a partner with the Florida Prepaid College Foundation for several years, with the relationship growing stronger every year in collaboration with Take Stock in Children. BBBS Miami is considered to be a model of the Big Brothers Big Sisters of America's Gold Standard of mentoring and was recognized by the State of Florida's Office of Juvenile Justice and Delinquency Prevention (OJJDP) as a proven prevention strategy.

Foundation Summary

The Foundation is the 501(c)(3) direct support organization for the Florida Prepaid College Board, which operates and oversees the Florida Prepaid College Plan. The Foundation's overarching goal is to achieve a sustained increase of Florida Prepaid College Foundation scholarship purchases through community outreach and new initiatives.

The Foundation was created in 1990 as a public/private partnership to provide scholarships to students who may not have otherwise had the opportunity to go to college. Scholarships are awarded to economically disadvantaged students who are at risk of dropping out of school and to other deserving students in need of assistance.

Businesses, organizations and community groups may purchase Plans through the Foundation. Since its inception, the Foundation has purchased more than 52,000 tuition and more than 5,000 add-plan scholarships, and, as of fall 2021, more than 33,000 Foundation scholarship recipients have attended college using their benefits.

Plans Offered

Foundation donors can choose from seven Florida Prepaid College Plans:

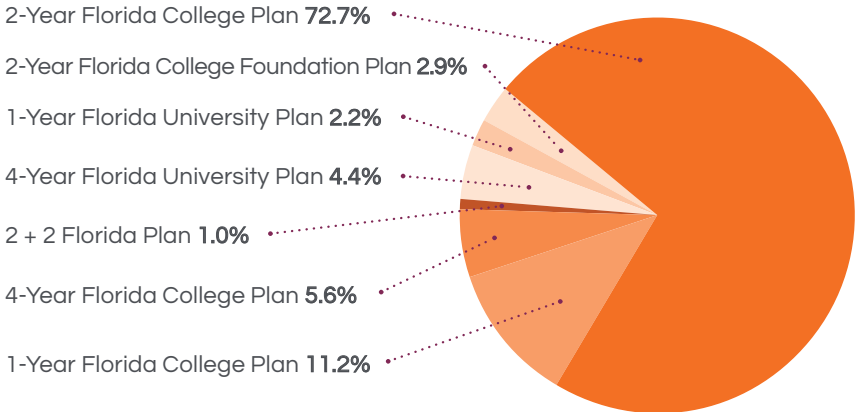
- 1-Year Florida College Plan (covers 30 lower division Florida College credit hours)
- 2-Year Florida College Plan (covers 60 lower division Florida College credit hours)
- 2-Year Florida College Foundation Plan (covers 72 lower division Florida College credit hours)
- 4-Year Florida College Plan (covers 60 lower division Florida College credit hours and 60 upper division Florida College credit hours)
- 2 + 2 Florida Plan (covers 60 lower division Florida College credit hours and 60 State University undergraduate credit hours)
- 1-Year Florida University Plan (covers 30 State University undergraduate credit hours)
- 4-Year Florida University Plan (covers 120 State University undergraduate credit hours)

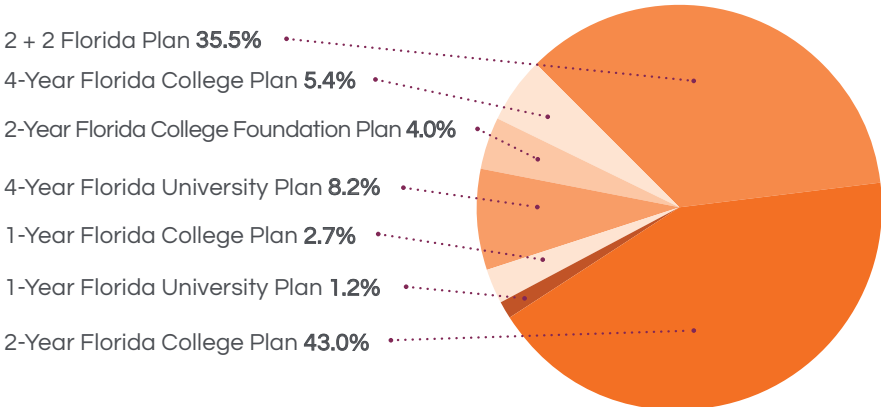
Contract Year 2021-2022

Dormitory Scholarships

The Foundation also offers optional, supplemental Dormitory Plan scholarships. The Dormitory Plan covers the cost of a standard, double-occupancy, air-conditioned dorm room at a State University in Florida. The Dormitory Plan can be used toward the cost of other university-held housing, including some fraternity and sorority houses, and at select Florida Colleges. The Dormitory Plan can be purchased in one-year increments, up to a total of four years. The Plan may be purchased for a student with a 4-Year Florida University Plan, a 1-Year Florida University Plan, or a 2 + 2 Florida Plan. To date, more than 1,000 Dormitory Scholarships have been awarded by the Foundation.

Stanley Tate Project STARS Scholarship Program

Stanley Tate Project STARS (Scholarship Tuition for At-Risk Students) is the Foundation's largest program, representing approximately 46,295 of the scholarships purchased by the Foundation. STARS is a matching scholarship program funded annually by the Florida Legislature and matched dollar-for-dollar by private sector donations. STARS targets low-income students who are at risk of dropping out of school and gives them the incentive and opportunity to plan and prepare for college.

STARS Donors

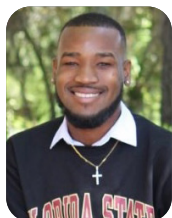
STARS donors include a group of public school foundations, school districts, community groups, businesses and other 501(c)(3) organizations that are dedicated to providing the children of Florida with guidance and educational opportunities.

STARS Students

To qualify for a STARS scholarship, students must be residents of Florida, economically disadvantaged (e.g. eligible for the free or reduced lunch program), and at risk of dropping out of school, and they must remain drug-free and crime-free. STARS students must also progress academically, meet school attendance requirements and abide by his/her school's code of conduct, and most meet with a mentor on a regular basis. STARS donors monitor each student's progress, providing support and encouragement throughout the middle and high school years.



STARS Student Success Stories: Take Stock in Children Palm Beach



Ja'Maar Nelson

**Current Status: Graduated,
Florida State University**

Ja'Maar Nelson is a recent graduate of Florida State University, where he earned a bachelor's degree in Family and Child Science. He is now enrolled in FSU's nursing program and wants to work as a psychiatric mental health registered nurse for a few years before pursuing a doctoral degree in health care.

Ja'Maar comes from a low socioeconomic upbringing, where he says higher education was often considered unattainable. He credits Take Stock in Children with providing him with opportunities and hope that allowed him to get the education he wanted.

"Take Stock and Florida Prepaid gave me the resources, support and mentoring that I needed to believe in myself and succeed in life," he says. "This scholarship serves as the difference between someone fulfilling their dreams or being overcome with life's difficulties."

Take Stock in Children Scholar Kori Diemer graduated from Jupiter High School in 2016. She attended the University of Florida and graduated in May 2020 with a degree in business and a minor in retailing systems.

She currently lives in Denver, Colo., where she is working for Bergdorf Goodman and was recently promoted to Assistant Promotions Manager. She executes all of Bergdorf's online events and gathers details for in-store and online promotions.

Kori enjoys completing agility courses with her dog, volunteering at local farmers' markets, and is a board member of the Rocky Mountain Gator club, an alumni group for the University of Florida. Kori says she is "forever grateful for what Take Stock in Children did for me!"

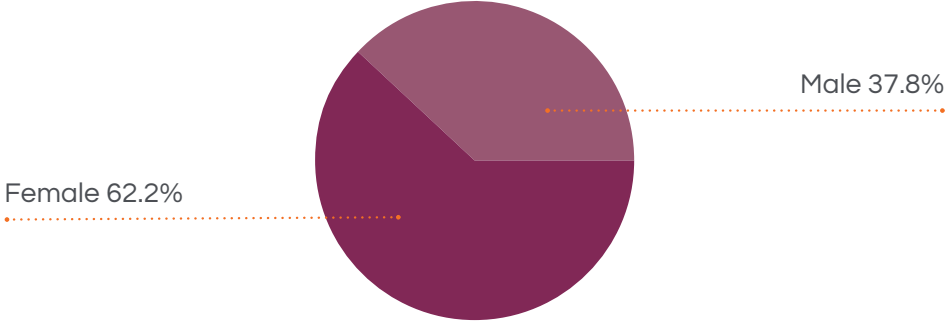

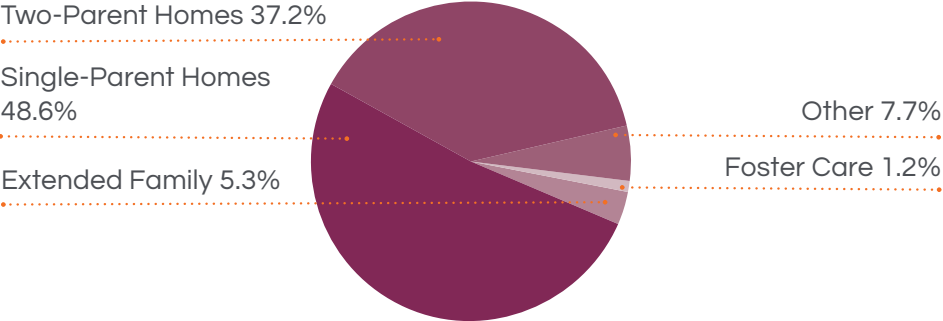

Student Demographics

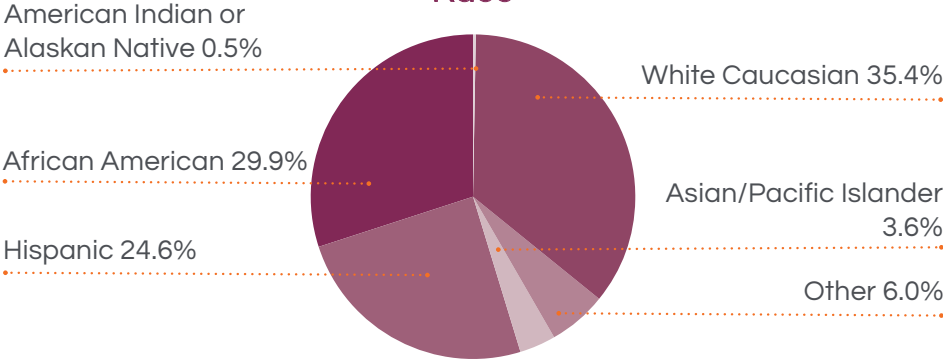

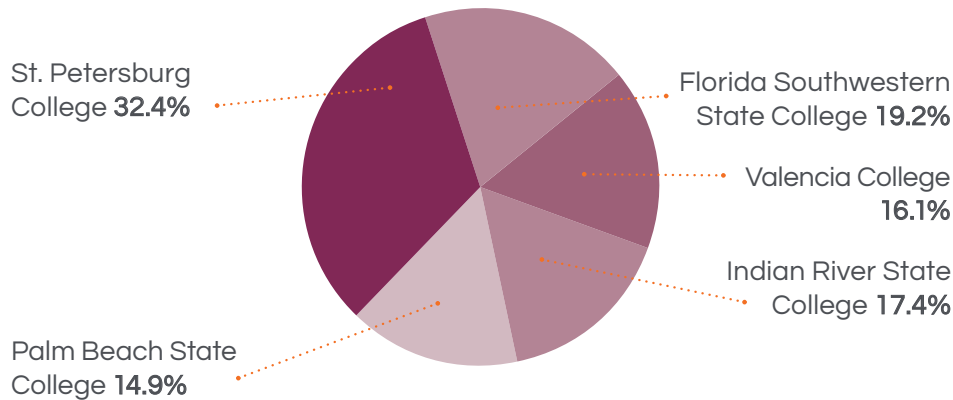

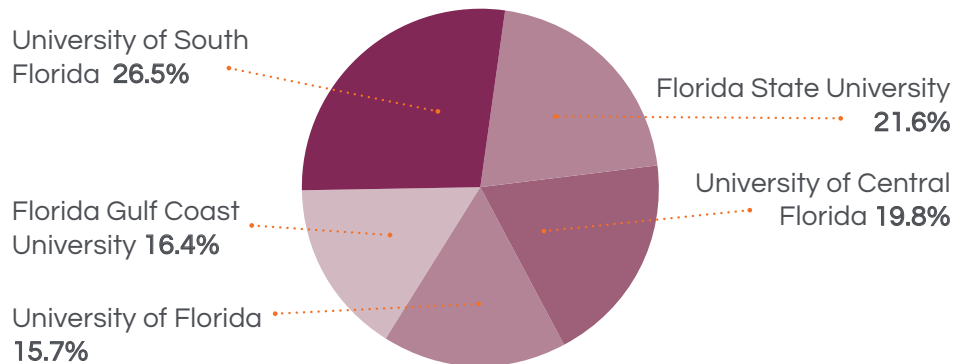
STARS Student Statistics

PATH TO PROSPERITY SCHOLARSHIP PROGRAM

In May 2021, the Florida Prepaid College Foundation and the Florida Chamber Foundation launched the Path to Prosperity Scholarship Program, a first-of-its-kind joint initiative that brings together Florida businesses, organizations and private donors to provide up to \$20 million in college scholarships to children living in poverty in Florida's most impoverished zip codes.

Through the end of fiscal year 2021-2022, we announced commitments from 10 organizations, with funds matched by the Florida Prepaid College Foundation to provide over \$300,000 in 2-Year Florida College Path to Prosperity Scholarships for 80 students residing in the Florida Chamber Foundation's priority zip codes.

One partner, The Florida Blue Foundation, donated \$50,000 and when combined with the Foundation's dollar-for-dollar match, \$100,000 in scholarship funds provided 2-Year Florida College Plan Scholarships to 26 students across the state.

Eligible students must meet scholarship criteria, which include being enrolled in grades 9 – 12, crime-free and drug-free, and economically disadvantaged.

Black History Month Scholarship

The Florida Prepaid College Foundation sponsored the Governor’s Annual Black History Month Essay for 4th through 12th grade students throughout Florida. The essay contest celebrates Black History Month and honors the

historic contributions and accomplishments of African American leaders, educators and entertainers from Florida. The theme of the 2022 essay contest was “Celebrating African American Contributions to Florida’s History.” The Foundation donated a 4-Year Florida College Plan to each of the three winners during a reception at the Governor’s Mansion, commemorating Black History Month.

The essay contest had three winners in grades 4-12 who will receive a 4-Year Florida College Plan scholarship. The winners were Aryana Sahai, Kurukulasuriya Nishini and Sidjourney Knight. The Foundation contributed \$26,842 to purchase scholarships for these students.



Hispanic Heritage Month Scholarship

The Foundation sponsored the Governor’s Annual Hispanic Heritage Month Essay Contest for 4th through 12th grade students throughout Florida. The essay contest celebrates Hispanic heritage, family and culture. The theme for the 2022 essay and art contests was “Celebrating The Achievements of Hispanic Floridians.”

The Florida Prepaid College Foundation donated a 2-Year

Florida College Plan to each of the six winners. The winners were Andrew Diaz, Jasmine Guerva, Aeden Arquiza, Braydon Lee, Emma Cevallos and Jayla Reyes-Camacho. The Foundation contributed \$24,189 to purchase scholarships for these students.



Celebrating Sunshine State Scholars

In April, the Foundation joined the Florida Department of Education in celebrating Florida’s highest-achieving 11th grade science, technology, engineering and mathematics (STEM) students at the 2022 Sunshine State Scholars Conference in Orlando. Fifteen honored students were awarded 1-Year Florida University Plan scholarships to attend one of Florida’s nationally top-ranked colleges or universities. These scholarships were funded through a donation from the AT&T Foundation and matching funds were provided by the Florida Prepaid College Foundation.

We Create New Beginnings

As the 501(c)(3), direct support organization for the Florida Prepaid College Board, the Foundation helps support the shared goal of making college more affordable and accessible for more Floridians.

We promote the importance of saving for college and give aspiring students the opportunity to build a better future through higher education. All of our match programs provide unprecedented value to donors by leveraging matching dollars to maximize the impact of scholarship gifts.

Challenge Match Scholarship Programs

The Florida Prepaid College Foundation now has four private match scholarship programs to promote access to higher education in Florida. The primary goal of all of our Challenge Match scholarship programs is to provide higher education opportunities to those who might not otherwise afford them.

Academic A+ Scholarship Program

Provides scholarship match opportunities to organizations that recognize students who are making exemplary efforts in the 4th – 12th grade classroom while overcoming significant challenges in their lives.

First Generation Scholarship Program

Provides scholarship match opportunities to Florida's public university and state college foundations to fund First Generation students who aspire to attend their institution.

In-Demand Career Scholarship Program

Provides scholarship match opportunities to organizations working to empower students and assist Florida businesses with a ready pipeline of educated personnel to meet the workforce needs of the future.

LEGACY Scholarship Program

Provides scholarship match opportunities to community-based organizations that would like to pay tribute to an outstanding citizen or organization that exemplifies leadership through education excellence and/or community or state service.

We match our dollars with those of a private donor or 501(c)(3) organization to reduce the purchase cost of specific scholarships.

Private Donors

The Foundation has many private donors, including community groups, businesses, hospitals and churches that are making a college education a reality for students in their communities throughout Florida. These private donors purchase Foundation scholarships with 100 percent private sector donations, which permits them to set their own selection criteria. Private donor scholarship funds are not matched by the Foundation.

Academic A+: Transformative opportunities through exemplary Florida principals

Since 2017, the Florida Prepaid College Foundation has partnered with Florida TaxWatch (FTW) through the annual award of our Academic A+ scholarships to deserving students in the schools where select principals are recognized through the FTW Principal Leadership Awards program.

To date, 49 scholarships have been awarded for a total match amount of \$99,000.

Challenge Match First Generation Scholarship Program

The Challenge Match scholarship program awards First-Generation scholarships for students “first in their family” to attend a 2-Year College or 4-Year University.

Since the Foundation program’s inception in 2017, more than 200 students have entered a First-Generation program through a match scholarship opportunity with the Foundation. In 2022 alone, 46 students have received the benefit of just over one million dollars in support.

The Eda & Cliff Viner Community Scholars Foundation, The University of Florida and Florida Atlantic University continue to produce amazing results through their sustained commitment to their students and in partnership with the Florida Prepaid College Foundation.



Challenge Match Featured Students

Challenge Match Legacy Scholarship Program



The Legacy Scholarship Program provides matching opportunities to community-based organizations that wish to pay tribute to an outstanding citizen or organization that exemplifies leadership through education excellence and/or community or state service.

The Eda and Cliff Viner Community Scholars Foundation was established in 2015 to provide scholarships, mentoring and social services to improve the opportunities for academic and life success for disadvantaged students in Boca Raton and Delray.

To date, The Eda and Cliff Viner Community Scholars Foundation has funded over \$350,000 in Legacy match scholarships to award 4-Year University Plans to students attending Florida institutions.

Special Opportunity Scholarship Program



The Miami Marlins Foundation and the Florida Prepaid College Foundation announced a partnership to award 18, 2-Year Florida College Scholarships to students impacted by the Surfside condominium collapse in South Florida.

The Miami Marlins Foundation provided \$76,000, and, with matching funds from the Florida Prepaid College Foundation, \$151,000 in scholarships were awarded through the Foundation's Special Opportunity Scholarship (SOS) program.

Financial Summary



Financial Summary of the Stanley G. Tate Florida Prepaid College Foundation

The financial summary below provides the Foundation's financial activities for the fiscal year ended June 30, 2022. Please read this information in conjunction with the Foundation's financial statements, which can be found on the Foundation's website at www.floridaprepaidcollegefoundation.com.

The Foundation's financial position is measured in terms of resources (assets) owned and obligations (liabilities) owed on a given date. The excess of assets over liabilities is equal to the net assets. The Foundation's financial position, or net assets, is one way to measure the Foundation's financial condition.

Statement of Financial Position
