Chair's Message



It is my pleasure to share with you the Stanley G. Tate Florida Prepaid College Foundation Annual Report for the Fiscal Year ending June 30, 2024.

In the past year we have grown our donor base and impact for the Foundation, as we saw new corporate donors join the momentum of our statewide Path to Prosperity initiative aimed at opening the door to higher education for students living in Florida's most poverty-stricken zip codes. We also continue to partner with education foundations and other community organizations to provide scholarships for students throughout the state.

To date, the Foundation has awarded nearly 60,900 Florida Prepaid College Plan scholarships, and more than 37,500 Foundation scholarship recipients have gone to college using their benefits. The Scholarship Tuition for At-Risk Students (STARS) Program remains the Foundation's largest initiative, representing 83 percent of the scholarships purchased by the Foundation.

Project STARS provides Florida Prepaid College Plan scholarships to lowincome students who are at risk of dropping out of middle and high school, giving them the incentive and opportunity to plan and prepare for college as they receive mentoring. Project STARS scholarships are funded from an annual legislative appropriation and matching contributions from partners, including Take Stock in Children, local education foundations, school districts and other community-based organizations.

This past year, Coke Florida committed \$1.4 million, for an impact of \$2.8 million and 250 scholarships over 10 years, to support the Path to Prosperity Scholarship Program. The program is in partnership with the Florida Chamber Foundation to bring together Florida businesses, organizations and private

donors to provide up to \$20 million in college scholarships to children living in Florida's most impoverished zip codes. The Florida Prepaid College Foundation is matching contributions dollar-for-dollar to allow donors to maximize their impact.

Other Path to Prosperity Scholarship Program donors include Florida Power & Light Company, Florida Blue Foundation, VyStar Credit Union, Availity, and George Snow Scholarship Fund among others. More than 729 students have already been awarded a Path to Prosperity Scholarship to date.

On behalf of the Foundation Board, I would like to express our gratitude and appreciation to all of our donors and partners from around the state. Together, we are helping Florida students aim for a stronger and more prosperous tomorrow.

Foundation Facts

The Stanley G. Tate Florida Prepaid College Foundation provides a taxdeductible opportunity for businesses, community groups and other 501(c)(3) not-for-profit groups to purchase Florida Prepaid College Plan scholarships for Florida children.

- Foundation scholarships may be purchased for children through the 12th grade. The children must be Florida residents at the time of selection and award.
- The cost of a scholarship is based on the type of Plan and the projected college enrollment year. Foundation scholarships must be paid for in a single lump sum.
- Foundation scholarships can be used at any of Florida's 12 public universities or 28 state colleges. The value of the scholarship may also be transferred to most private colleges in Florida, select technical schools in Florida and most out-of-state colleges (depending on the scholarship plan type).
- When students are ready for college, they enroll in classes and Florida Prepaid pays their school directly.
- The Stanley Tate Project STARS (Scholarship Tuition for At-Risk Students) scholarship program is the Foundation's hallmark program and offers a 1:1 scholarship match.
- The Challenge Match scholarship programs offer a 1:1 scholarship match and can be purchased during specific application windows.



Featured Donors & Partners

The Florida Prepaid College Foundation is proud to partner with all of the organizations we work with throughout the state. Since 1991, the Foundation has partnered with over 160 Project STARS donors. During Fiscal Year 2023-2024, 68 donors purchased 3,092 STARS tuition scholarships with privately donated funds matched by state-allocated funds.





Walton Education Foundation (WEF) is a 501(c)(3) organization serving the educational community of Walton County by mobilizing support and resources for its public, charter and magnet schools aligning classroom grants, school-wide grants, community partnerships and as the county's lead agency for the Take Stock in Children program. WEF has proudly purchased and placed 150 scholarships in the hands of determined and driven students of the Walton County School District with over 100 having activated their scholarship to attend college.

To date, 600 students have benefited from a Jump Start Scholarship, coordinated through the Consortium of Florida Education Foundations, as part of the STARS program. The Jump Start Program aims to provide a fasttrack career/college strategy for high school seniors through enrollment in technical and vocational certification programs available at state colleges or technical institutions.

Our partners consist of education foundations, school districts, community groups, businesses and corporations dedicated to making the dream of a college education come true. 

Foundation Summary

The Foundation is the 501(c)(3) direct support organization for the Florida Prepaid College Board, which operates and oversees the Florida Prepaid College Plan. The Foundation's overarching goal is to achieve a sustained increase of Florida Prepaid College Foundation scholarship purchases through community outreach and new initiatives.

The Foundation was created in 1990 as a public/private partnership to provide scholarships to students who may not have otherwise had the opportunity to go to college. Scholarships are awarded to economically disadvantaged students who are at risk of dropping out of school and to other deserving students in need of assistance.

Businesses, organizations, and community groups may purchase plans through the Foundation.

Foundation donors can choose from seven Florida Prepaid College Plans:


- 1-Year Florida College Plan (covers 30 lower division Florida College credit hours)

- 4-Year Florida University Plan (covers 120 State University undergraduate credit hours)


Contract Year 2023-2024

Dormitory Scholarships

The Foundation also offers optional, supplemental Dormitory Plan scholarships. The Dormitory Plan covers the cost of a standard, double-occupancy, air-conditioned dorm room at a State University in Florida. The Dormitory Plan can be used toward the cost of other university-held housing, including some fraternity and sorority houses, and at select Florida Colleges. The Dormitory Plan can be purchased in one-year increments, up to a total of four years. The Plan may be purchased for a student with a 4-Year Florida University Plan, a 1-Year Florida University Plan, or a 2 + 2 Florida Plan. To date, more than 1,500 Dormitory Scholarships have been awarded by the Foundation.

Stanley Tate Project STARS Scholarship Program



Stanley Tate Project STARS Scholarship Program

Stanley Tate Project STARS (Scholarship Tuition for At-Risk Students) is the Foundation's largest program, representing approximately 50,350 of the scholarships purchased by the Foundation (includes JumpStart, STARS and Path to Prosperity scholarship programs).

STARS Donors

STARS donors include a group of public school foundations, school districts, community groups, businesses, and other 501(c)(3) organizations that are dedicated to providing the children of Florida with guidance and educational opportunities.

STARS Students

To qualify for a STARS scholarship, students must be residents of Florida, economically disadvantaged, and at risk of dropping out of school, and they must remain drug-free and crime-free. STARS students must also progress academically, meet school attendance requirements, abide by his/her school's code of conduct, and most meet with a mentor on a regular basis. STARS donors monitor each student's progress, providing support and encouragement throughout the middle and high school years.







STARS Student Statistics

Path to Prosperity Scholarship Program

In May 2021, the Florida Prepaid College Foundation and the Florida Chamber Foundation launched the Path to Prosperity Scholarship Program, a first-of-its-kind joint initiative that brings together Florida businesses, organizations and private donors to provide up to \$20 million in college scholarships to children living in poverty in Florida's most impoverished zip codes.

Through the end of fiscal year 2023-2024, we announced commitments from 12 organizations, with funds matched by the Florida Prepaid College Foundation to provide over \$2.6 million in Path to Prosperity Scholarships for over 500 students residing in the Florida Chamber Foundation's priority zip codes.

In 2022, the Florida Blue Foundation. generously provided the first significant donation to the Path to Prosperity program, which was matched by the Florida Prepaid College Foundation, providing \$100,000 in 2-Year Florida College Plan Scholarships to 26 students in Broward, Duval, Hillsborough and Orange counties.

Since then, Florida Blue has donated each year to provide additional scholarships to students for a total of 84 scholarships awarded including 32 in 2024 to include Miami-Dade, Florida Blue Foundation

partnered with Goodwill Industies of North Florida, Tampa Bay Technical High School, Bowers Whitley, Valencia College Foundation, Broward Education Foundation, Jones High School (Orlando) and Big Brothers Big Sisters of Miami to select qualified students. The total contribution from Florida Blue is \$171,103.78, matched dollar for dollar from Florida Prepaid College Foundation amounting to \$342,207.56.

Path to Prosperity Scholarship Program

In August 2023, Coke Florida introduced the Coke Florida Refreshing Minds ScholarshipSM, a 10-year, \$2.8 million student scholarship commitment made possible through a dollar-for-dollar match with the Florida Prepaid College Foundation.

The Coke Florida Refreshing Minds ScholarshipSM will cover tuition and most local fees for qualifying students pursuing higher education at a Florida public four-year university, two-year college, or technical/ vocational school.

Coke Florida and the Florida Prepaid College Foundation partnered with Big Brothers Big Sisters Association of Florida and the Florida Alliance of Boys & Girls Clubs to deliver the scholarship program. In 2024, twenty-five deserving students were awarded the Coke Florida Refreshing Minds Scholarship.

Black History Month Scholarship

The Florida Prepaid College Foundation sponsored the Governor's Annual Black History Month Essay for 4th through 12th grade students throughout Florida. The essay contest celebrates Black History Month and honors the

historic contributions and accomplishments of African American leaders, educators and entertainers from Florida. The theme of the 2024 essay contest was "Celebrating Florida's African American Heroes and Their Contributions to Freedom."

The Florida Prepaid College Foundation donated a 2-Year Florida College Plan to each of the six winners during a reception at the Governor's Mansion, commemorating Black History Month. The winners were Jeremiah Gordon, Skyla Brooks, Adrienne Menard, Katherine Newkirk, Daniel Macias and Joseph Gordon III. The Foundation contributed \$24,196 to purchase scholarships for these students.



Hispanic Heritage Month Scholarship

The Florida Prepaid College Foundation sponsored the Governor's Annual Hispanic Heritage Month Essay Contest for 4th through 12th grade students throughout Florida. The essay contest celebrates Hispanic heritage, family and culture. The theme for the 2023 essay and art contests was "Celebrating Florida's Hispanic Heroes and Their Contributions to Freedom."

The Florida Prepaid College Foundation donated a 2-Year Florida College Plan to each of the six winners. The winners were Norah Hall, Angelica Urena, Camila Romero, Joseph Norman, Jasmyn Cabral, and Bella Jiron. The Foundation contributed \$24,342 to purchase scholarships for these students.

Native American Heritage Month Scholarships

The theme for the Governor Ron DeSantis' and First Lady Casey DeSantis' 2023 Native American Heritage Month Essay Contest was "Highlighting Native American Heroes and Their Accomplishments."

The Foundation supported the Governor's Native American Heritage Month event through the award of six 2-Year Florida College scholarships to essay contest winners in 4th through 12th grade throughout Florida. The winners were Maddox Newkirk, Dylanie Peak, Rooney Walker, Isabella Moya, Varshini Venkat, and Joshua Law. The total scholarship cost was \$22,921.

We Create New Beginnings

As the 501(c)(3), direct support organization for the Florida Prepaid College Board, the Foundation helps support the shared goal of making college more affordable and accessible for more Floridians.

We promote the importance of saving for college and give aspiring students the opportunity to build a better future through higher education. All of our match programs provide unprecedented value to donors by leveraging matching dollars to maximize the impact of scholarship gifts.

We match our dollars with those of a private donor or 501(c)(3) organization to reduce the purchase cost of specific scholarships.

Challenge Match Scholarship Programs

The Florida Prepaid College Foundation now has four private match scholarship programs to promote access to higher education in Florida. The primary goal of all of our Challenge Match scholarship programs is to provide higher education opportunities to those who might not otherwise afford them.

Academic A+ Scholarship Program

Provides scholarship match opportunities to organizations that recognize students who are making exemplary efforts in the 4th – 12th grade classroom while overcoming significant challenges in their lives.

First Generation Scholarship Program

Provides scholarship match opportunities to Florida's public university and state college foundations to fund First Generation students who aspire to attend their institution.

In-Demand Career Scholarship Program

Provides scholarship match opportunities to organizations working to empower students and assist Florida businesses with a ready pipeline of educated personnel to meet the workforce needs of the future.

LEGACY Scholarship Program

Provides scholarship match opportunities to community-based organizations that would like to pay tribute to an outstanding citizen or organization that exemplifies leadership through education excellence and/or community or state service.

Private Donors

The Foundation has many private donors, including community groups, businesses, hospitals, and churches that are making college education a reality for students in their communities throughout Florida. These private donors purchase Foundation scholarships with 100 percent private sector donations, which permits them to set their own selection criteria. Private donor scholarship funds are not matched by the Foundation.

Challenge Match Scholarship **Programs**



Challenge Match Academic A+ Scholarship **Program**

Since 2017, the Florida Prepaid College Foundation has partnered with Florida TaxWatch (FTW) through the annual award of our Academic A+ scholarships to deserving students in the schools where select principals are recognized through the FTW Principal Leadership Awards program. Each principal

recognized is provided the opportunity to select one student at their school to receive a 2-Year Florida College Scholarship Plan. These scholarships are awarded to financially challenged students in at-risk schools. This year, we expanded our existing Academic A+ Program to award 15 exemplary students in grades 4-12. To date, 73 scholarships have been awarded for a total cost match amount of \$268,451.

Challenge Match First Generation Scholarship Program

The Challenge Match scholarship program awards first generation scholarships for students who are "first in their family" to attend a 2-Year College or 4-Year University. Since the Foundation program's inception in 2017, more than 300 students have entered a first generation program through a match scholarship opportunity with the Foundation. In 2024 alone, 45 students have received the benefit of just over \$875K in support.





Special Opportunity Scholarship Program

In May, the Foundation joined the Florida Department of Education in celebrating Florida's highest-achieving 11th grade science, technology, engineering and mathematics (STEM) students at the 2024 Sunshine State Scholars Conference in Orlando. Thirty-Seven students were awarded 1-Year Florida University Plan scholarships to attend one of Florida's top-ranked colleges or universities. These scholarships were funded through a donation from State Farm, and matching funds were provided by the Florida Prepaid College Foundation.
